ORDER:

In the GO first read above, the Government have constituted Lake Protection Committee for preservation and protection of lakes in Hyderabad Metropolitan Development Authority.

2. In the GO second read above, the Government have appointed the Additional Collectors (Local Bodies) of Hyderabad, Ranga Reddy, Medchal-Malkajgiri, Yadadri-Bhongir, Medak, Sangareddy and Siddipet Districts as Nodal Officers for field level coordination with different departments involved in survey and finalization of lake boundaries.

3. The Government further considerer that it is necessary and appropriate to designate a Senior Officer with the responsibility of inter-departmental coordination involving survey, revenue, irrigation, local bodies, etc., in demarcation, protection and development of lakes within the GHMC and HMDA jurisdiction.

4. In view of the above, the Government hereby designate Sri C. Sudharsan Reddy, IAS., Secretary, MA&UD as Special Commissioner, Lake Protection on FAC basis for demarcation, with the responsibilities of demarcation, protection, development and rejuvenation of all lakes within the jurisdiction of GHMC and HMDA. He shall deal with all departments concerned in resolving the issues related to protection of lakes within GHMC and HMDA. He shall be reporting to the Special Chief Secretary, MA&UD in respect of all issues and developments related to lakes within GHMC and HMDA jurisdiction.
